#### Call to Order

# **Officer Reports**

• Chairman (Bruce Rollins):

Everyone on the LMSC Board needs to be registered before the end of the year.

Scholarships for victims of Hurricane Harvey was discussed. Paper Registrations only will be accepted. Registrations must be in on or before January 31, 2018. Gulf LMSC will pay the full amount of the USMS registration fee for 2018 for those who cannot afford it due to the impact of Hurricane Harvey.

Bruce described the Safety – Tags – Form and Holder for emergency information. The form is located on the Gulf Website under Administration. A water-proof envelope is available to attach to a swimmer's swim bag. Anyone interested in obtaining a water proof envelope, please send an order to Bruce Rollins by 12/31/17 for distribution in 2018.

- Sanctions (Kris Wingenroth): No report
- Treasurer (Mark Hahn):

The current ending balance as of October 31, 2017 is \$21,185.07 along with \$30,000.00 in CDs for a total of \$51,185.07.

• Coaches/Fitness (Robin Tompkins):

Robin Tompkins discussed the following fitness events:

## Old Business

To encourage additional volunteer opportunities in the Gulf, a possible change in the bylaws for Article IV Section Elections and Terms of Officers was discussed. The current language reads:

Elections and Term of Office – The Officers shall be elected at the annual business meeting in even numbered years by a majority of all voting representatives present. Each officer shall serve for the term of two years or until his or her successor is chosen. No person may serve more than two consecutive terms in the same office. When a suitable replacement cannot be found, an officer may continue to serve with the concurrence of the majority of the House of Delegates.

The proposed revised language is set forth below:

Elections and Term of Office – The Officers shall be elected at the annual business meeting in even numbered years by a majority of all voting representatives present. Each officer shall serve for the term of two years or until his or her successor is chosen. No LMSC Chair may serve more than two consecutive terms.

After discussion, the proposed change was not voted on and the by-laws will not be revised.

#### Emmet Hines Zones Award – Kris and Mark

Leadership Award for service to each LMSC either through coaching, officiating or service within each LMSC honored at convention

#### Jessie Coon Award Nominees – 2018

Each LMSC is to present to the Zone Chair at least one nominee for the Jesse Coon Award annually due in January.

#### Long-term planning for Zone Meets – 2019 and 2020

Bruce recommended that the planning for Zone Meets should be longer term in order to secure good meet locations.

# **Open Water LMSC Event(s)** – 1<sup>st</sup> will be held on 5/5/18 – 288 Lake

Seth emphasized promoting and encouraging participation in current open water events held in the gulf region versus trying to establish new events. Seth outlined several open water events that were currently planned.

Current insurance rates are \$100 per event for LMSC open water events plus \$5 per athlete with 20 participants.
